**STIPULATION AND ORDER TO
CONTINUE SETTLEMENT
CONFERENCE**

(First Request)

18 Pursuant to LR IA 6-1, and LR 26-4, Plaintiff/Counter-defendant Zap's
19 Electrical, LLC ("Zap's") and Defendant/Counterclaimant Monarch Construction, LLC
20 ("Monarch," and collectively with Zap's the "Parties"), by and through their
21 undersigned counsel of record, hereby stipulate and agree to continue the settlement
22 conference in this matter, currently scheduled to take place on June 23, 2020.

23 On April 22, 2020, the Parties submitted a stipulated motion to amend the
24 scheduling order to allow additional time for discovery in this matter. [ECF No. 37]. In
25 that stipulation, the Parties agreed to a continuance of the settlement conference to a
26 date after the close of discovery on September 25, 2020. *Id.* The Court granted the
27 stipulated motion and entered an Amended Scheduling Order on April 23, 2020;

1 however, the settlement conference remained on calendar for June 23, 2020. [ECF No.
2 38].

3 Based upon the extended discovery cut-off and the public health crisis inhibiting
4 the Parties' ability to conduct certain discovery, including depositions, the Parties
5 stipulate and agree and request a continuance of the settlement conference until a date
6 after September 25, 2020.

7 The Parties submit this Stipulation and request the continuance of the
8 settlement conference for good causes and not for the purposes of delay.
