ORDER GRANTING

Pursuant to Federal Rule of Civil Procedure 6(b)(1) and Local Rule IA 6-1, Plaintiff Nevada Select Royalty, Inc., by and through counsel, and Defendant, by and through counsel, (collectively hereinafter, the “Parties”), hereby stipulate to extend the time for the Parties to file responses to the pending Motions for Summary Judgment (ECF Nos. 101 and 102) as follows. The current deadlines to respond are November 20, 2024 and the requested extension thereof is for only five additional days. This is the first request for an extension of these deadlines.

- 7 4. The parties hereby stipulate to extend the time for each to file their respective
8 responses to the Motions for Summary Judgment until, up to, and including
9 November 25, 2024.
- 10 5. Pursuant to LR IA 6-1, this is the first request for an extension of time for the
11 relevant deadlines and the parties submit that good cause supports this request.
12 Plaintiff requested additional time to file its Response to Defendant's Motion for
13 Summary Judgment due to pressing motions that arose in other cases.
14 Additionally, the parties agreed to extend the deadline for the respective responses
15 to avoid having their respective replies due shortly after the upcoming
16 Thanksgiving holiday. This Stipulation is submitted in good faith and not to cause
17 undue delay in this case.
