22	Rule 3 of the Supplemental Rules for Social Security.	
23	(4) From this point forward, Plaintiff must serve a copy of every pleading or other	
24	document submitted for consideration by the Court upon the defendant or, if an	
25	appearance has been entered by counsel, upon the attorney. Plaintiff must include with	
26	the original of each document to be filed with the Court a certificate stating that a true and	
27	correct copy of the document was served on the defendant, or counsel, if the defendant	
28	has an attorney. Under Local Rule 5-1 the pro	oof of service must show the day and manner
