Finally, Defendants are advised that the Ninth Circuit has held that a corporation and other unincorporated associations may only appear in federal court through an attorney. *United States v. High Country Broadcasting Co., Inc.*, 3 F.3d 1244 (9<sup>th</sup> Cir.

1 1993); *Licht v. America West Airlines*, 40 F.3d 1058 (9<sup>th</sup> Cir. 1994). Therefore, Defendants  
2 shall file a substitution of counsel on or before **Friday, April 4, 2025**. Ville 837, LLC is  
3 advised that if substitute counsel had not entered an appearance by April 4, 2025, the  
4 Court will issue a Report and Recommendation that Ville 837, LLC's answer be stricken,  
5 and a default be entered.
