1. AT WHICH TIME LT JAMES BROWN SAID "YOU  
WILL RECEIVE YOUR KOTHEN DIET AT LUNCH"

A. MY KOTHEN DIET WAS NEVER PUT UP AND I HAD A  
PROBLEM I SAID TO AN OFFICER HE TOLD ME I WOULD  
GET A CELL FEED FOR LUNCH. I DID AT 1326 HOURS

A. BREAKFAST - HARD BOILED EGGS AGAIN AMOUNTS THREE I WANT TO I COULD GIVE THEM AWAY. I DID

C. DINNER THE SAME MEAL AS LUNCH

D. AT LUNCH AND DINNER I REFUSED TO ACCEPT THE MEAL I CAN NOT CONSUME AND GAVE THEM BACK AT THE DINING LINE

5. SATURDAY THE 28TH APRIL 2007

THE SAME MEAL PLAN AT BREAKFAST

A. I SPoke TO THE INMATE WHO MAKES UP THE DINE LINE HE TOLD ME THAT THEY HAD KIDNEY DOGNUTS BUT HIS BROTHER TOLD HIM TO GIVE ME THE HARD BOILED EGGS "IT'S MY JOB"

- C. DINNER SAME AS FRIDAY 27TH 2007 ENTER PORJEN

6. SUNDAY 25TH APRIL 2007

BREAKFAST - CIVILIAN LINE / CALLED BY THE NAME OF PHIL. WHO I HAD ALWAYS REJECTED WHO DURING THE WEEK TOLD ME "I THOUGHT WE GOT RID OF YOU"

A. WHEN I CAME UP TO THE BLIND SERVING SLOT I SAID AS I ALWAYS DO IN THE DINING HALL NO. 2 - GOOD MORNING THEN I SAID MR WOLFF (PPD 9.32) KOSHER DIABETIC. THE CIVILIAN PHIL PASSED OUT MY BROWN BAG. WITH IT CAME INTO THE DINING HALL I SAW THAT ALL INMATES IN THE DINING HALL HAD AN ORANGE. THAT I ASKED IF THERE WAS AN ORANGE IN MY BAG - CIVILIAN PHIL'S REPLY "MY DIABETIC'S DO NOT GET ANY ORANGES" I THEN LOOKED IN MY BAG AND FOUND 3 HARD BOILED EGGS. I TOOK ONE OUT AND AS I DID ON OTHER DAYS AND SAID "I DO NOT EAT HARD BOILED EGGS" THE CIVILIAN LINE SERVED 1/10 EAT THEM THEM (WHAT YOU GET AS I TOOK OUT THE SECOND HARD BOILED EGG AND IT WAS BEHIND THE AUNT DREW DOWN ON STEEL DOOR SAID "YOU TAKE THEM BACK TO YOUR UNIT AND EAT THOSE EGGS" I PLACED THE SECOND EGG ON THE METAL CUPBOARD TRAY AND LEFT - TOLD OFFICER COOK AND HE LOOKED AT ME THAT I HAD DONE BUT THE 3RD HARD BOILED EGG ON THE TABLE PROVIDED SOME MILK ON MY BUN OF 3/6 OF OR CORN FLAKES) AND A CORRECTION OFFICER COULD COME OVER AND SAID CHARLIE HE WANT YOU TO I GAVE MY ID TO A CORRECTION OFFICER WHO GAVE IT TO THE CIVILIAN LINE SERVED PHIL.

7. AS I LEFT THE DINING HALL HE A CPL ASKED ME IF I THOUGHT THE EGG AT THE LINE SERVER. I SAID NO YOU KNOW ME BETTER THAN THAT. HE THEN SAW THE WHITES OF THE EGGS I SAID 'NO' THAT ALSO WILL GIVE ME A PROBLEM. AM I WTR, HE WAS ALSO CONCERNED.

8. I RETURNED TO MY UNIT THE SOUTH DIVISION AM I WENT TO THE SOUTH DIVISION CONTROL ROOM CALLED THE BUSS. I ASKED TO SEE THE SHIRT COMMANDER
