I, Jeff Perkins, Upon Oath Do Hereby Depose And State As Follows:

1. I am currently employed by the New Hampshire Department of Corrections, State Prison for Men ("NHSP"), 281 North State Street, Concord, New Hampshire. I make this affidavit based on my personal knowledge.
2. I am the Food Service Supervisor for the NHSP. I have been employed by the NHSP as Food Service Supervisor for the last 23 years. I received my education in food service preparation from Southern Maine Technical Institute.
3. As the Food Service Supervisor, I am responsible for the overall planning and preparation of inmate meals including meals for religious diets.
4. As a religious practice, Inmate Charles Wolff consumes a Kosher diet.
5. Attachment A is an example of the Kosher diet menu. Breakfast and Lunch are prepared by the Corrections kitchen staff. Kosher dinner entrees are provided at dinner time.
6. The Department of Corrections purchases it's prepackaged Kosher meals from a vendor known as Good Source.

7. Attachment B is an example of the nutrition facts of the prepackaged Kosher meals that are provided to inmates who require Kosher foods as a religious diet.
8. Based on my experience and expertise in food service preparation, the Kosher menu provides proper nutrition.

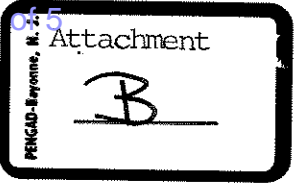

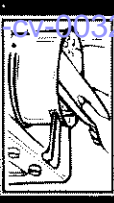
