"MOTION"

1. I REQUEST TO RECONVENE THE EVIDENTIARY HEARING ON MY BEHALF HELD AT THE UNITED STATES DISTRICT COURT OF THE DISTRICT OF NEW HAMPSHIRE ON WEDNESDAY THE FIRST DAY OF AUGUST 2007, BEFORE HIS HONOR JAMES R. MUIRHEAD UNITED STATES MAGISTRATE JUDGE. THIS IS THE RELIEF I REQUEST.

REASON:

1. I WISH TO BE SWORN IN UNDER OATH "TO TELL THE WHOLE TRUTH AND NOTHING BUT THE TRUTH", IN THE UNITED STATES DISTRICT COURT OF THE DISTRICT OF NEW HAMPSHIRE.
2. TO TELL THE HORRIFIC TIME I EXPERIENCED DURING MY STAY ~~AT~~ THE HEALTH SERVICE DEPARTMENT HERE AT THE NEW HAMPSHIRE PRISON CONCORD, NEW HAMPSHIRE, IN A DOUBLE LOCKED STATION CALLED "ISOLATION-2".

3. TO TELL WHAT INMATE ROBERT MONTGOMERY A VOLUNTEER IN THE HEALTH SERVICE WAS TELLING OTHER INMATES ABOUT MY STAY IN THE HEALTH SERVICE DEPARTMENT WHO NEVER ENTERED MY DOUBLE LOCKED ROOM ISOLATION. - 2nd
4. TO TELL WHY ONE OF MY KEY WITNESSES WAS MOVED TO ANOTHER UNIT AFTER MY STAY IN THE HEALTH SERVICE DEPARTMENT FROM TUESDAY THE 7TH FROM 0930 HOURS TO TUESDAY THE 14TH 1200 HOURS 2007, IN THE MONTH OF AUGUST.
5. TO ASK THE ^{Honorable} COURT TO CONCUR AND GRANT THAT THE NEW HAMPSHIRE STATE POLICE DENTAL DEPARTMENT DOES COME UNDER THE AUSPICE FOR THE NEW HAMPSHIRE DENTAL DEPARTMENT IS UNDER THE DIRECTION OF DR. ROBERT MACLEOD MD AND GRANT THE RELIEF AS STATED AT THE RECONVEINING OF MY REQUESTED EVIDENTIARY HEARINGS.
6. TO PROVIDE A HAND COPY OF THE MEDICATIONS I WAS TAKING TO INCLUDE THE DATE OF AUGUST 1ST 2007, WHICH IS MUCH LATER THAN WHICH THE NEW HAMPSHIRE DEPARTMENT OF JUSTICE "THE ATTORNEY GENERAL'S OFFICE" AS STATED BY JUDGE LEONARD SEID UNDER BOTH AND OTHER MEDICAL DOCUMENTS.

7. TO PROVIDE IN HAND COPY FORM OF THE HIGHEST WEIGHT I WAS WITH A PHOTO OF MYSELF AT THE TIME OF MY REQUESTED ACCOMMODATION EVIDENTIALLY HEARING AS THE REASON THAT CAUSED MY OBESITY.

8. TO TELL THE EXTRA POOL DIET IN A KOSHER FORM WHICH IS NOW VERY QUESTIONABLE THAT I AM RECEIVING NO ~~WITH~~ THE DONUTS OR DANISH THAT MR NICK STACY STATED UNDER OATH DURING MY EVIDENTIALLY HEARING HELD ON WEDNESDAY THE 1ST OF AUGUST 2007.



TO REQUEST THAT THE HONORABLE COURT ORDER THAT MY ENTIRE KOSHER DIET BE REPACKAGED TO INCLUDE MY ENTIRE, KOSHER MEAT ^{with} WHEAT BREAD AND FRUIT ALL BE REPACKAGED PLUS TO ALLOWING IN THE KITCHEN AND TO BE GIVEN TO MYSELF IN THE FORM AND NOT ORDERED BY ANY PERSON OTHER THAN MYSELF AND TO KEEP TO THE LACK OF KNOWLEDGE OF THE KITCHEN STAFF AND ATTORNEY ANDREW B. CLEMONS OR WHOEVER IS ASKED WHO IS NOT KOSHER HERE AT THE NEW YORK HOTEL.

DATED "APRIL 2, 2007, ON PAGE "3" OF SAID DOCUMENT OF THE LAST COMPLETE SENTENCE, "THE PRISON'S CULINARY ARTS PROGRAM DOES NOT PROVIDE FOR KOSHER PREPARED MEALS." MY REQUEST WILL STOP THE COMPRESSION OF THE KITCHEN STAFF AND THAT OF THE DEPARTMENT OF JUSTICE OF THE STATE OF NEW HAMPSHIRE TO INCLUDE THEM ATTORNEYS (M.M.) ANDREW B. LUGANOWSKI GUIDE.

- a. THE KITCHEN PROVIDED ISLAMIC INMATES A KOSHER PREPARED 10 EXTREMES OF WHICH ONLY 4 ARE HALAL, CERTIFICATION OF A TRUE HALAL PRODUCT.
- b. I HOLD TRUE TIES TO THE FIRST SEWING BATHING SHUL IN LOWELL, MASSACHUSETTS.
- c. I TRAVELED WITH NOW HADNY BOTH ONE OF THE THREE LAWS OF THE LAWS OF COUNSEL OR 3 LAWS

- d. THIS WILL NOT HAVE THE PRE-JUDICE VIEWS THAT HAVE BEEN ESTABLISHED AGAINST MYSELF BY THE DEPARTMENT OF CORRECTIONS OF THE STATE OF NEW HAMPSHIRE TO EXCLUDE THE DEPARTMENT OF JUSTICE AND ATTORNEY ANDREW B. UVERA NOW ESQUIRE OF SAID STATE
- e. THAT THE HONORABLE COURT GRANT MY CALORIES BE GRADED ON A SOLID FOOD BASE RATHER THAN ITEMS SUCH AS MILK, INSTANT BREAKFAST ETC FOR THESE TYPE OF PRODUCTS PASS THROUGH AND FORM ONLY A SMALL BOWEL MOVEMENT TO DO THE LACK OF SOLID MASS.
10. TO TELL THE HONORABLE COURT THE TRUTH OF MY CONVICTION WITH A PSI OF 1 TO 3 AND GIVEN TWO 10 TO 20 YEAR CONCURRENT SENTENCE FOR A CRIME I DID NOT COMMIT.
