3. NUMBERS ONE (1) AND TWO (2) IS ON RECORD DURING MY EMERGENCY PRELIMINARY IN-JUNCTION HEARING HELD ON AUGUST 1ST 2007 AT THE UNITED STATES DISTRICT COURT DISTRICT OF NEW HAMPSHIRE.
4. THAT INMATE JAMES KEACH A KITCHEN WORKER HAS NO CONTACT WITH ANY OF MY KOSHER DIET. THIS IS THE REASON I REQUEST

REASONS:

1. ON MONDAY SEPTEMBER 3RD (LABOR DAY) 2007. I RECEIVED HAND BOILED EGGS FOR BREAKFAST AND LUNCH. I GAVE THE BREAKFAST EGGS TO MR. KEACH AND THIS BREAKFAST WAS PACKED BY INMATE JAMES KEACH. THE LUNCH EGGS I GAVE BACK,

2. AT DINNER I RECEIVED CHARLES PAUL'S BROWN BAG WHICH HAD TWICE AS MUCH FOOD IN IT THEN MINE EVER HAD. QUESTION WHY SHOULD I EAT CHASLES PAUL A MUSLIM RECEIVE TWICE AS MUCH FOOD AS A JEW. THAT IS MYSELF.
3. ON TUESDAY SEPTEMBER 4TH 2007, I RECEIVED HARD BOILED EGGS AND LETTUCE THEM CRUSHED TO MR. STEVE DAYTON A CIVILIAN. I HAD LPT OF 1% MILK FOR BREAKFAST.
4. I SAW I MATE DAME KEACH THRU KNOWING OF TUESDAY SEPTEMBER 4TH 2007 AND EXPLAINED TO HIM (WHICH HE KNOWS I DO NOT EAT EGGS) AND THAT MR. RICK STACY TOLD JUDGE DAME L. MURKHEAD I WILL NOT RECEIVE EGGS. IN RESPONSE I MATE DAME KEACH TOLD ME "YOU EAT WHAT I GIVE YOU OR YOU DON'T EAT." (A KITCHEN WORKER)
5. THIS IS THE TYPE OF TREATMENT I RECEIVED MOSTLY FROM MINE BILL DURING MY STAY AT H/C.
6. "THE PRISON AND ITS STAFF WILL NOT DO WHAT THE COURT ORDERED IT TO DO" STATED TO MYSELF BY COLLECTIONS OFFICER MARK DONA IN THE FRI MORNING ON TUESDAY AUGUST 7TH 2007 "AND YOU CAN TELL THAT TO THE JUDGE" I AM.
7. THE POINT IS WILL THE PRISON ABIDE TO THE ORDER OF THE UNITED STATES DISTRICT COURT OF THE DISTRICT OF NEW HAMPSHIRE AND WITH AND BY WHAT MEANS WILL BE

THE CHECKS AND BALANCES BE DONE. THIS SHOULD NOT BE THE KITCHEN OR HEALTH SERVICES OR ANY NEW HAMPSHIRE STATE POLICE EMPLOYEE. WHEN I MET WITH THE JUDGE OF JUSTICE.
