1. MR. RICK STACY ON THE SERVING LINE IN DINING HALL NUMBER ONE (2) THIS MORNING AT APX. 0550 HOURS TOLD ME I WOULD RECEIVE EGGS AND REFUSED TO SERVE MYSELF BREAKFAST.
 2. I REQUEST THAT THE UNITED STATES DISTRICT COURT OF THE DISTRICT OF NEW HAMPSHIRE THAT I RECEIVE THREE (3) NUTRITIOUS MEALS PER DAY WHICH NONE HAVE SOLID EGGS IN THEM, AND TO ORDER THE DEPARTMENT OF COLLECTIONS TO COMPLY,
 3. THAT I BE PUT ON CELL FEEDS. THIS WILL ALLOW MYSELF AGAIN NOT TO HAVE CONTACT WITH KITCHEN STAFF.
 4. THAT MR. RICK STACY BE HELD IN CONTEMPT OF COURT.

REASONS:

2. HIS HONOR MAGISTRATE JUDGE JAMES R. MUIRHEAD TOLD MR. RICK STACY I AM ENTITLED TO THREE (3) NUTRITIOUS MEALS PER DAY WHICH I HAVE NOT SINCE APRIL 25TH 2007, THAT WAS 133 DAYS HAS PASSED.
