"MOTION"

1. ON THE ABOVE DATE I AGAIN RECEIVED THREE(3) HARD BOILED EGGS, TWO SLICES OF NON-KOSHER TOAST, ONE $\frac{3}{4}$ OZ BOX OF CORN FLAKES AND TWO $\frac{1}{2}$ PINTS OF 1% MILK SERVED BY MR. STEVE DAYTON FOR BREAKFAST.
2. THE PART THAT I COULD CONSUME FOR BREAKFAST WAS $\frac{3}{4}$ OZ OF CORN FLAKES AND 1% PINT OF MILK.
3. LIVING ON ALMOST NOTHING I BECAME AT A HIGH RISK OF BECOMING UNCONSCIOUS AGAIN AND TO HAVE ANOTHER HEART PROBLEM. DUE TO MY DIABETES AND HYPERTENSION WHICH CAUSED MYSELF TO HAVE A HEART ATTACK IN 2005.
4. I REQUEST NOW THAT THE HONORABLE UNITED STATES DISTRICT COURT OF THE DISTRICT OF NEW HAMPSHIRE ISSUE AN ORDER TO THE NEW HAMPSHIRE DEPARTMENT OF COLLECTIONS TO PROVIDE MYSELF WITH THREE(3) NUTRITIOUS KOSHER MEAL PER DAY NOT TO INCLUDE ANY EGGS OR ANY STICK AND THAT ALL FOOD TO FOLLOW THE JEWISH LAW OF KASHERUS FOR WHICH MY ORIGINATED IS IMPRISONED THIS IS THE REASON I REQUEST.

REASON:

1. THE DEPARTMENT OF COLLECTIONS IS AGAIN IN CONTEMPT OF THE AGREEMENT MADE BETWEEN HIS HONOR MAGISTRATE JUDGE OF THE UNITED STATES JAMES L. MULLEND ON WEDNESDAY THE 15TH OF AUGUST 2007. THAT MR. NICKSTOCK THE SUPERVISOR OF THE

KITCHEN SUPERVISOR OF THE KITCHEN THAT I WOULD RECEIVE ALTERNATE KOSHER ITEM IN PLACE OF EGGS.

2. ONE EGG HAS 240 MG OF CHOLESTEROL WHICH PUTS MYSELF IN A HIGH RISK FACTOR TO HAVE ANOTHER HEART ATTACK AND IN MY CASE INTAKE OF DIETARY CHOLESTEROL SHOULD BE HEART LESS THAN 300 MILLIGRAM PER DAY.
3. AT THIS TIME I HAVE AT LEAST ONE (1) MINOR DIFFUSE COLONAL DISEASE INVOLVING THE LEFT COLONAL SYSTEM AFTER THE MEDICAL PROCEDURE ON MAY 31ST 2006 OF STENTING OF MY PROXIMAL AND RIGHT DISTAL COLONAL ARTERY USING DRUG-ELUTING STENTS.
4. WHEN I HAD EX-RAY ON APRIL 25TH 2006 IT WAS DISCOVERED THAT I HAVE FAIRLY HEAVY VASCULAR CALCIFICATION IDENTIFIED IN THE PELVIS AND GROIN AREA.
5. MY PROSTATE CANCER WAS DISCOVERED ONLY A PSA OF 2.3. WHY WOULD MANCHESTER UNO WAIT UNTIL MY PSA WAS OVER 4.0. QUITE POSSIBLE DR. PLATTMAN KNOWING I WAS OVER 50 YEARS OLD AND THAT MY FATHER PASSED ON FROM COLON CANCER AND WHEN I WAS 10 YEARS OLD I HAD A BOWEL RESECTION.
6. AS OF TODAY I WILL NOT GO TO BREAKFAST TO AVOID ANY PROBLEMS UNTIL MY BREAKFAST MEAL ARE PROVIDED TO MYSELF THAT ARE NUTRITIOUS WITHOUT ANY FORM OF ESS AND ANY NON-KOSHER FOOD THAT IS BEING PROVIDED TO MYSELF.

7. I WILL GO TO BREAKFAST AFTER I AM
ADVISED IN WAITING ROOM THE KITCHEN
SUPERVISOR. I HAVE NO OTHER OPTION.
