"NOTICE OF APPEAL"

NOW COMES THE PLAINTIFF, CHARLES DAY WOLFE, PRISONER, AND IN FORMER PAUPER I PRAY THE HONORABLE UNITED STATES COURT OF APPEALS WILL HEAR MY "NOTICE OF APPEAL"

THE FOLLOWING ARE GROUNDS TO SUPPORT MY "NOTICE OF APPEAL"

1. ON JULY 10, 2006 I FILLED MY MOTION TO PROCEED IN FORMER PAUPER WITH CUSTODIAL CERTIFICATE.

REASON 1. MY KITCHEN DIST WAS STUNDED BY DEFENDANT DAILY AFTER BEING TOLD BY STATE DEPT THE KITCHEN SUPERVISOR THAT I WAS NOT EATING THE HEAVY STOVE KITCHENMOY WHICH HAD PROBLEMS WITH IN THE PAST WITH PROBLEMS WILL REGISTERED.

2. MY WEIGHT DROPPED FROM 187 POUNDS TO 140 POUNDS.

3. DURING MY VIDEO CONFERENCE OF PROTECTIVE ORDER MAY 14TH 2007 HIS HONOR JAMES A. MULLHEAD UNITED STATES MAGISTRATE JUDGE, HIS HONOR STATED & LOOKED FORWARD AT THIS TIME I WAS 168 POUNDS, AT THIS TIME I AM 136 POUNDS THAT I WENT FROM 187 POUNDS TO 140 POUNDS, TO 168 POUNDS I AM NOW 136 POUNDS.

4. I HAVE HAD DIETITIAN (S) FOR MOST OF THE LAST 192 DAYS FOR VEGETABLES AND WITHIN 30 ITEMS OF FRESH FRUIT.

5. I HAVE HEART CONDITION, DIABETIC, NOT CONTROLLED, A CHRONIC CARE PATIENT WITH MULTI-MEDICAL ISSUES. TO EXPLAIN STOMACH PROBLEMS WHICH I TAKE THREE (3) MEDICATIONS FULL.

6. I AM TO BE SEEN BY A MEDICAL PROVIDER, MD, PHD OR NURSE PRACTITIONER AT LEAST EVERY 90 DAYS. MY LAST APPOINTMENT THAT I SAT WITH A MEDICAL PROVIDER WAS WITH DR. CELIA ELLERMAN MD ON MAY 31, 2007. THAT IS OVER 156 DAYS AGO.

7. MY PRELIMINARY INDUCTION HEARING WAS HELD ON 8-1-2007, BEFORE HIS HONOR JAMES R. MURHEAD UNITED STATES MAGISTRATE JUDGE, FOR A PROPOSED KOSHON DIET THAT HE PROVIDED THREE (3) TIMES A DAY WITHOUT HAD BULED ESSY, AND TO BE NUTRITIOUS.

8. I WAS GIVEN A ^{TEST} BIRTH HEALTH CERTIFICATE IN A DOUBLE CHAMBERED ROOM WITH NO WAY TO CONTACT ANYONE UNLESS SOMEONE WALKED INTO THE FIRST CHAMBER OR SOMEONE FROM HOTEL AS THEY WALKED BY, FOR THE EVENT OF A FIRE OR THE JANITORIAL WENT OFF, IN THESE SITUATION ROOM, THE BENCH HAS A HILL ABOUT DYING, EVEN PLAIN A SIMPLE MEDICAL NEED.

9. AN AGREEMENT WAS MADE DURING THE HEARING HELD ON 8-1-2007 THAT I WOULD NOT RECEIVE ESSY OR HAD BULED. I DID NOT PICKED MUTUAL OF CALIFORNIA FOR RECEIVING.

10. ON OCTOBER (), 2007 HIS HONOR JAMES R. MURHEAD UNITED STATES MAGISTRATE JUDGE FILED HIS "REPORT AND RECOMMENDATION" IN THAT HIS HONOR DENIED MY REQUEST FOR PRELIMINARY INDUCTION HEARING AND THAT OF COUNTERPART.

11. I PICKED AN ORDER TO HIS HONOR "REPORT AND RECOMMENDATION"

12. ON OCTOBER 30, 2007, H/1 HENRY PAUL BARBADORO UNITED STATES DISTRICT JUDGE OF THE UNITED STATES DISTRICT COURT OF THE DISTRICT OF NEW HAMPSHIRE, APPROVED THE "RECENT BIRTH RECOMMENDATION" OF H/1 HENRY MATTHEWS SUBO MURHEAD DECEMBER OCTOBER 17, 2007.
