ORDERED that, pursuant to L. CIV. R. 101.1(c)(2), John Lewis Jr., Esquire, shall pay the annual fee to the New Jersey Lawyer's Fund for Client Protection in accordance with New Jersey Court Rule 1:28-2 within twenty (20) days from the date of the entry of this Order, enclosing with payment a completed Form PHV-5 (attached); and it is further

ORDERED that, pursuant to L. Civ. R. 101.1(c)(3), John Lewis Jr., Esquire, shall make a payment of \$150.00 on each admission, payable to the Clerk, United States District Court; and it is further

ORDERED that John Lewis Jr., Esquire, shall be bound by the General and Admiralty Rules of the United States District Court for the District of New Jersey, including but not limited to the provisions of Local Rule 103.1, <u>Judicial Ethics and Professional Responsibility</u>, and Local Rule 104.1, <u>Discipline of Attorneys</u>; and it is further

ORDERED that, pursuant to L. Civ. R. 101.1(c)(4), John Lewis Jr., Esquire, shall be deemed to have agreed to take no fee in any tort case in excess of the New Jersey Court Contingency Fee Rule, Rule 1:21-7, as amended.
