Dear Judge Reyes:

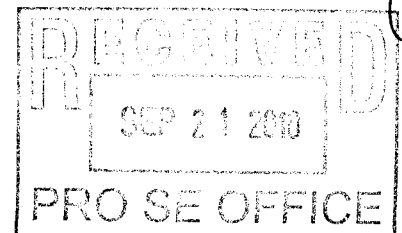
We are Defendants in this litigation (Ana Bove and Polina Dolginov, as well as the Corporate Defendants "Anna Bove Company, LLC" in the name of its president Alex Sakirski, and also "Anna Bove Embroidery Supplies, Inc." in the name of its president Alex Sakirski).

Thank you very much for the letter that Your Honor issued last week, which explained us in detail many questions that we didn't understand earlier.

We were very glad about Your Honor's words that we, as individual defendants, can protect the corporate rights. Earlier we were under impression that due to the purely technical fact that the corporation owned the copyrights and other IP, a big problem would arise if a technical default would be ruled. To reserve an ability to protect our property, into which we've been putting so much hard work for so many years, we've agreed to assign IP rights from the corporation to Ana Bove. See Exhibit #1. This way we would be able to guarantee that the technical default against the corporation won't damage our ability to defend our vitally important assets.

If, due to the changes in IP now belonging personally to Ana Bove,

some Claims should be changed, we're more than ready to do so, by Your Honor's direction.

Due to the fact that this case was being maintained without any true distinction regarding the owner of IP rights, we're sure that no delay or prejudice of anyone's rights and opportunities will happen, due to this change.

At the same time, this minor change, from the point of view of the dispute itself, could give insure us that a technical default against the corporations won't deprive the individual Defendants of their rights regarding Intellectual Property, to create which they've been working for these so many years.
