"I have to work".

He dose not give me my money, so I come back to N.Y. one week or so later Mohamed come back to N.Y and told me he didnt get the money that we went for. I ask Mohamed what was in the black bag that you left in my van he answered it was Viagra.

30-45 days later (November 15, 2003) Mohamed went to Kentucky with another people or crew, they were arrested with 10,000 ecstasy pills in Kentucky, I dont was with them or I know about it and I have no idea how many people and how was arrested.

In April 5, 2005 F.B.I arrested me for that delivery I had made in 2003, I didnt know what Mohamed was dealing with and I never saw any drugs by my eyes all my life prior.
