## Hi Alex,

We will need to sit down and review the documents at some point. However, for right now, our priority is Eugene's deposition. I have spoken to Daniel Axelrod and he has made it very clear that we are to turn over any chats/emails in Eugene's possession prior to the deposition on Monday. I have not received any of these documents from you for review. I would need to receive them today in order to be able to review them prior to turning them over to the oppositon. Finally, I'm not sure if you are aware of this, but one of the papers served by the oppposition identifies Eugene as Ana's possible drug source. Eugene needs to be prepared for questions on Monday on this topic.
