

STIPULATION OF SETTLEMENT

This Stipulation of Settlement (the "Stipulation") is entered into the 28th day of March, 2012 between VADIM MIKHLYN ("VM"), INGA MIKHLYN ("IM") and ABC ALL CONSULTING, INC. ("ABC") (VM, IM and ABC collectively, "Plaintiffs") and ANA BOVE ("AB"), ANNA BOVE COMPANY, LLC, (the "AB LLC") ANNA BOVE EMBROIDERY, INC. (the "AB CORP.") and POLINA DOLGINOV ("PD") (AB, AB LLC, AB CORP., and PD collectively "Defendants") and ALEXANDER SAKIRSKI ("AS") and TRADEINDICATOR, INC. ("TI") (AS and TI collectively, "State Action Defendants," and, together with Defendants and Plaintiffs, the "Parties").

WHEREAS, the Plaintiffs and Defendants are parties to an action pending in the Federal Court for the Eastern District of New York, entitled Vadim Mikhlyn, Inga Mikhlyn and ABC All Consulting, Inc. v. Ana Bove, Polina Dolginov, Anna Bove Company, LLC and Anna Bove Embroidery, Inc., Docket No.: 08-cv-3367 (the "Federal Action"); and

WHEREAS, ABC and State Action Defendants are parties to an action pending in the Supreme Court of the State of New York, Kings County, entitled ABC All Consulting, Inc. v. Alexander Sakirski and Tradeindicator, Inc., Index No.: 13502/11 (the "State Action"); and

WHEREAS, the Parties desire to compromise their differences and resolve the Federal Action and State Action by settlement in order to avoid further expense and inconvenience.

THEREFORE, IT IS HEREBY AGREED:

THREADELIGHT TRADEMARK

1. The ThreaDelightT trademark, Reg. No. 3,090,179 (the "TM") shall be the joint intellectual property of VM, IM, and AB LLC (by way of a 2008 transfer of rights from AB to AB LLC) (each a "Joint TM Owner" and collectively "Joint TM Owners"). A specimen of the TM is annexed hereto as Exhibit A. Each Joint TM Owner shall be entitled to use the TM and license the use of the TM to entities controlled by all or some of the Joint TM Owners but not by any other persons or entities (without having to account to any of the other Joint TM Owners) on, for and in connection with sale, distribution and advertising of embroidery threads and embroidery nets. None of the Joint TM Owners shall use or license the use of the TM on, for or in connection with any goods or services other than embroidery threads without the express written consent of all of the other Joint TM Owners. Each Joint TM Owner shall use its best efforts to include the registered mark symbol (®) after the TM on packaging and labels.

2. The Joint TM Owners shall cooperate in renewing and maintaining all rights and good will in and to the TM and all

registrations for the TM, including, without limitation, by executing declarations or use and incontestability, applications for renewals and all other necessary documents and papers and filing same as necessary. All costs associated with such renewal and maintenance of the TM shall be shared equally between and among the Joint TM Owners. Failure to contribute to such renewal and maintenance pursuant to this paragraph shall not be a material breach of this agreement.

3. Any Joint TM Owner may initiate the process of making a filing contemplated by paragraph 2 by giving written notice to all other Joint TM Owners ("Filing Notice"), which notice shall be given not earlier than 30 days prior to the earliest date on which the filing is permitted to be made under applicable law and no later than 60 days prior to the last date on which such filing may be made. The Filing Notice shall identify the filing to be made or other action to be taken, the prescribed period and deadlines for taking such action, the costs associated therewith (including reasonable attorneys' fees) and shall include or identify the paperwork to be executed and required attachment or enclosures to the filing. No later than the earlier of: (x) 90 days after receipt of the Filing Notice or (y) 30 days prior to the last date on which such filing may be made (not including any grace periods or extensions that may be obtained), each of the other Joint TM Owners who wish to

participate in the filing shall respond in writing stating that they will participate in the filing and agreeing to pay their share of the associated costs. Any Joint TM Owner who does not respond within the period specified in the preceding sentence, or responds that s/he does not wish to participate shall be deemed to be a Defaulting Joint TM Owner under paragraph 4 below.

4. A Joint TM Owner who elects to participate in the filing or other action identified in a Filing Notice but does not pay his or her equal share of the costs associated with renewing and maintaining the TM shall be liable for the unpaid amount to the other Joint TM Owner(s) that advanced such an amount on his or her behalf. If these costs are not repaid within ninety (90) days from written notification to the such non-paying Joint TM Owner from the Joint TM Owner(s) who advanced payment on his or her behalf, then such Joint TM Owner, as well as any Joint TM Owner who did not elect to participate in the subject filing, shall be deemed to be a "Defaulting Joint TM Owner". All of the Defaulting Joint TM Owner's rights and interests in and to the TM shall immediately (upon expiration of the applicable periods specified in this Stipulation) and automatically be deemed to have been sold, assigned, conveyed and transferred to the other Joint TM Owners pro rata ("Default Transfer"); and the Defaulting Joint TM Owner shall have no

further rights to use the TM or any derivative of confusingly similar trademark or to identify him or herself as having been the owner of or otherwise associated with the TM. To the extent the payment on behalf of the Defaulting Joint TM Owner is not advanced in equal shares by the other Joint TM Owners, the Joint TM Owner(s) who advanced more than their equal share shall be entitled to pro-rata reimbursement from the other Joint TM Owner(s) within 90 days of notice given to such other Joint TM Owner(s).

5. In the event of a Default Transfer pursuant to paragraph 4, the non-defaulting Joint TM Owners shall be entitled to file evidence of and record such transfer with the U.S. Patent and Trademark Office and any other appropriate governmental authorities, and the Defaulting Joint TM Owner shall do all such things and execute all such documents and filings as may be necessary therefor.

6. In the event that the Joint TM Owners are unable, after reasonable effort, to secure the signature of the Defaulting Joint TM Owner on any application, assignment, or other document or instrument relating to the TM in the event of a Default Transfer, each Joint TM Owner hereby irrevocably designates and appoints each of the other Joint TM Owners as his or her agent and attorney-in-fact, to act for and in his or her behalf and stead to execute and file any such documents and to

do all other lawfully permitted acts to make filings, record and further evidence the Default Transfer with the same legal force and effect as if executed by him or her.

7. None of the Joint TM Owners shall transfer, sell, convey, assign, license, encumber, or consent to any third party's use, or in any other way modify his or her rights in and to or give up any control over the TM without the express, written consent of the other Joint TM Owners. Except that the TM can be used in connection with the embroidery business operated by any entity at least half of which is owned by one of the Joint TM Owners.

8. Each Joint TM Owner shall safeguard and maintain the established goodwill symbolized by the TM and shall maintain quality standards with respect to the design, manufacture, sourcing, sale and distribution of embroidery threads and thread nets that are no less stringent than the quality standards used by them prior to the date hereof.

9. A breach of Paragraphs 1-8 above, by any party, shall not to be considered a material breach of this Stipulation.

EMBROIDERY DESIGN COPYRIGHTS

10. Concurrently herewith, AB LLC is executing and deliver to ABC the Copyright Assignment in the form attached hereto as Exhibit B, pursuant to which AB LLC and ABC shall become joint

owners of the copyrights in and to the embroidery design sets registered with the U.S. Copyright Office as set forth in Exhibit C hereto ("Copyrighted Designs"), such that each of them may, except as specifically provided in this Stipulation, exercise throughout the world all rights and remedies provided or reserved to a copyright owner under the U.S. Copyright law and applicable laws of other jurisdictions. The foregoing joint ownership shall not require either AB LLC or ABC out to account to the other for any royalties or other amounts received in respect of the Copyrighted Designs, which right to an accounting is hereby forever waived by each of AB LLC and ABC.

11. AB LLC and ABC are and shall remain joint owners of all rights, title and interest (including, without limitation, copyright rights) in and to the embroidery designs set forth in Exhibit D hereto ("Unregistered Designs" and, together with the Copyrighted Designs, the "Embroidery Designs"), such that each of them may, except as specifically provided in this Stipulation, exercise throughout the world all rights and remedies provided or reserved under the law of any applicable jurisdiction. The foregoing joint ownership shall not require either AB LLC or ABC out to account to the other party for any payments or royalties or other amounts received in respect of the Unregistered Designs, which right to an accounting is hereby forever waived by each of AB LLC and ABC. Neither AB LLC nor ABC

at any time shall apply, file or otherwise take any action to register any intellectual property rights, including, without limitation, copyright right) in or to the the Unregistered Designs with any governmental authority in any jurisdiction throughout the world (including, without limitation, the U.S. Copyright Office) without prior written consent of the other.

12. Paragraph 11 above is for their mutual benefit and convenience of the parties hereto. Nothing contained in paragraph 11 shall be construed as a legal admission that the Unregistered Designs are in the public domain.

13. The Defendants, hereby warrant and represent that:

a. Title to Copyrighted Designs. To the best of their knowledge, AB LLC is the sole and exclusive owner of all right, title and interest in and to the Copyrighted Designs; that no other entity or person has any rights, interests or claims in, to or with respect to any of the Copyrighted Designs (except those that are licensed from Natalie Dolginov pursuant to the License Agreement, dated March 15, 2012, a copy of which annexed hereto as Exhibit E); that the Copyrighted Designs are not subject to any security interests, pledges, attachments, liens, licenses, conditional sales agreements, encumbrances, claims, leases or other charges; that

the copyright registrations for the Copyrighted Designs were duly and properly applied for and obtained from the United States Copyright Office, and are valid and subsisting. In turn, Plaintiffs represent and warrant that they have no information and have not taken or authorized any action which is contrary to the representations above in paragraph 13(a).

b. Title to Unregistered Designs. To the best of their knowledge, Plaintiffs and Defendants are the sole and exclusive owners of all right, title and interest in and to the Unregistered Designs; that no other entity or person has any rights, interests or claims in, to or with respect to any of the Unregistered Designs (except those that are licensed from Natalie Dolginov pursuant to the License Agreement, dated March 15, 2012, a copy of which annexed hereto as Exhibit E); that the Unregistered Designs are not subject to any security interests, pledges, attachments, liens, licenses, conditional sales agreements, encumbrances, claims, leases or other charges. In turn Plaintiffs represent and warrant that they have no information and have not taken or authorized any action which is contrary to

the representations above in paragraph 13(b).

Plaintiffs and Defendants further represents that none of them have registered or applied or taken any action to register the Unregistered Designs with any governmental authority in any jurisdiction throughout the world (including, without limitation, the U.S. Copyright Office).

c. Authority. AB LLC has the full power, authority and all rights necessary to assign the copyrights to and in the Copyrighted Designs (other than those expressly set forth in Exhibit E hereto), and to execute and deliver this Stipulation and to perform all of its obligations hereunder.

d. Noncontravention. The execution, delivery and performance of this Stipulation by AB LLC, will not: (i) violate any constitution, statute, regulation, rule, injunction, judgment, order, decree, ruling, charge, or other restriction of any government, governmental agency, or court to which the Parties are subject; or (ii) conflict with, result in a breach of, constitute a default under, result in the acceleration of, or create in any party the right to accelerate, terminate, modify, or cancel, or require any notice under any agreement, contract, lease,

license, instrument, or other arrangement to which any party hereto is a party, or by which a party hereto is bound. AB LLC is not required to give any notice to, make any filing with, or obtain any authorization, consent, or approval of any government or governmental agency in order for the parties to consummate the settlement contemplated by the Stipulation.

e. Litigation. There are no actions, suits, proceedings, orders, investigations or claims (other than the Federal Action and the State Action) pending or, to the knowledge of the Parties, threatened against or affecting the Parties, the validity of the copyrights in the Copyrighted Designs or the validity of any rights in the Unregistered Designs, alleging infringement or other violation of a third party's intellectual property right, at law or in equity or before or by the federal, state, municipal or other governmental department, commission, board, bureau, agency or instrumentality.

f. Agreements. Other than as specified herein, the Parties are not bound by any agreement or commitment, written or oral, which in any way

affects or encumbers its rights in or to the Embroidery Designs or grants any license or consent to use to any person or entity.

g. Disclosure. Neither this Stipulation nor any of the written statements, documents, certificates or other items prepared or supplied by the Parties with respect to the settlement contemplated hereby contain any untrue statement of a material fact or omit a material fact necessary to make the statements contained herein or therein not misleading. There exists no fact or circumstance which, to the knowledge of any party hereto materially adversely affects, or which could reasonably be anticipated to have a material adverse effect on, the ownership or use of the Embroidery Designs.

14. Except as permitted pursuant to this Stipulation, the Parties shall not transfer, license, encumber, consent to use by a third party or in any other way modify their rights in and to the Embroidery Designs, except that ABC may transfer, (in whole or in part) its rights in and to the Embroidery Designs to VM and/or IM or any entity owned or controlled by VM and/or IM; provided, that in no event may the copyright be transferred,

assigned or licensed to both VM and IM or to entities owned by them separately unless VM and IM remain married to each other.

15. Any and all digital image and design files (no matter in which stage of digitization) obtained by either party before April 2008 and currently in possession of any of the parties in the form of digital files, may be used by any of the parties to create derivative works and otherwise to finalize and modify such digitized designs ("Digital Files"). All modified versions and derivative works of such digitized files created by a party ("Derivative Works"), and all copyright and other intellectual property rights therein, shall belong exclusively to such party, and may be used by such party in any manner and for any purpose whatsoever.

16. In the event that AB LLC or ABC ("Transferor") receives and wishes to accept a bona fide written offer ("Offer") from a third party to purchase or obtain a license to all or any of its rights in and to the Embroidery Designs, the Transferor shall give written notice of the Offer, together with a copy thereof, to the other parties that have any rights in and to the Embroidery Designs (each an "Interested Party" and together "Interested Parties"), setting forth the price, identity of the proposed purchaser or licensee and all terms and conditions of the Offer. The Interested Party or Parties shall have the option to purchase or license all, but not less than

all, of the Transferor's rights subject to the Offer at the price and upon the terms of the Offer, such option to be exercised by written notice to the Transferor, sent within thirty (30) days after receipt by the other Interested Parties of notice of the Offer. If an Interested Party or Parties exercises such option in a timely manner, the closing of such purchase or license shall take place on a date specified by the Interested Party or Parties but not later than sixty (60) days after delivery of the notice of exercise of such option to the Transferor. If the Interested Party or Parties fail to timely exercise such option, the Transferor may sell or license the interest in and to the Embroidery Designs subject to the Offer at the same price and terms as set forth in the Offer but only to the purchaser identified in the notice of Offer, provided that such sale takes place no later than ninety (90) days after delivery of the notice of Offer to the other Interested Party or Parties and that the purchaser shall have executed and delivered to the Interested Party or Parties an appropriate supplement to this Stipulation pursuant to which it/he agrees to be bound by and comply with the terms and provisions of this Stipulation.

17. a) AB and AS hereby represent and warrant that they are the only members of AB LLC and that no other person or entity has any ownership interest in AB LLC.

b) VM and IM hereby represent and warrant that they are the only shareholders of ABC and that no other person or entity has any ownership interest in ABC.

18. a) In the event that any person or entity obtains an ownership interest in AB LLC, AB LLC shall deliver to Plaintiffs an appropriate supplement to this Stipulation pursuant to which the new member agrees to be bound by and comply with the terms and provisions of this Stipulation.

b) In the event that any person or entity obtains an ownership interest in ABC, ABC shall deliver to Defended an appropriate supplement to this Stipulation pursuant to which the new shareholder agrees to be bound by and comply with the terms and provisions of this Stipulation.

19. a) In the event that any member of AB LLC ceases to be a member for whatever reason, that member shall have no rights of any kind in or to the Embroidery Designs or Digital Files and the ownership of such copyrights shall remain with AB LLC.

b) In the event that any shareholder of ABC ceases to be a shareholder for whatever reason, that shareholder shall have no rights of any kind in or to the Embroidery Designs or Digital Files and the ownership of such copyrights shall remain with ABC.

20. In the event that AB LLC is dissolved, whether voluntarily, judicially or in any other manner, or if it becomes

insolvent, or if AB LLC becomes the subject of bankruptcy proceedings, whether voluntarily or not, under federal or State jurisdiction, or if AB LLC or its owners decide to transfer the intellectual property rights to another entity, then the copyright rights may be transferred to any single entity or person specified by owner(s) of AB LLC, which transferee shall be bound by this Stipulation, so that, in no event, will the intellectual property rights in and to the Embroidery Designs belong to more than one entity or person as successor to the rights of AB LLC.

21. In the event that VM and IM are no longer married to each other, then the copyright rights may be transferred to only one of them (or an entity controlled by one of them), which transferee shall be bound by this Stipulation, so that, in no event, will the intellectual property rights in and to the Embroidery Designs belong to more than one entity or person as successor to the rights of ABC.

CONTROL OF INTELLECTUAL PROPERTY LITIGATION

22. In the event that any Joint TM Owner learns of or reasonably suspects any infringement or imitation of the TM, or of any use by any person or entity of a mark similar to the TM, or in the event AB LLC or ABC (or any of their respective permitted successors or assigns) (together with all Joint TM

Owners, "Joint IP Owners") learns of or reasonably suspects any infringement of any of the parties' rights in the Embroidery Designs (such rights together with parties' rights in the TM, "IP"), such party shall promptly notify thereof all the other Joint IP Owners who have an interest in such IP. The Joint IP Owner who first learned of such potential infringement may (but shall not be obligated to) take whatever action it/she/he deems necessary or desirable to protect or enforce its and the other Joint IP Owners' rights to the subject IP, including the filing and prosecution of litigation, opposition or cancellation proceedings, the institution of federal or state proceedings and the right to settle; provided that such Joint IP Owner first obtain the consent of at least two of the other Joint IP Owners (or if there are only two Joint IP Owners of the subject IP, then of the other Joint IP Owner), which consent shall not unreasonably be withheld. Noncompliance with the terms set forth in this paragraph 22 shall not be considered a material breach of this Stipulation, if cured within twenty (20) days from written notice of such noncompliance.

23. In the event that the Joint IP Owner who first learned of the potential infringement elects not to exercise or fails promptly to exercise and pursue its rights under paragraph 22 above, any other Joint IP Owner with an interest in the subject IP shall have the right (but not the obligation), at its sole

expense and upon prior written notice to the Joint IP Owner who first learned of the infringement, to take such action as it deems necessary for the protection of its and the other parties' rights in and to the subject IP, including the institution of federal and state proceedings and the right to settle.

24. In the event any Joint IP Owner ("Prosecuting Party") takes action as permitted pursuant to paragraph 22 or 23 above, all the other Joint IP Owners shall provide, at the Prosecuting Party's expense, reasonable cooperation to Prosecuting Party in the execution of any documents or other similar assistance required for Prosecuting Party to take such steps, including joining Prosecuting Party as a party in any litigation where reasonably necessary for the conduct thereof.

25. Nothing in this Stipulation shall be construed to prevent some or all of the parties from taking action jointly in any infringement suit or other action with respect to the IP.

26. The party that takes action against an unauthorized third party use (unless the action is taken jointly) shall receive and retain any and all funds recovered in such an action, including, without limitation, the proceeds of any settlement thereof, after all parties are reimbursed for all out-of-pocket costs and expenses incurred by them in connection with such action. If the action is taken jointly, the parties will share the expenses pro rata, after payment of expenses, the

parties shall share pro rata any and all funds recovered in an action, including without limitation, the proceeds of any settlement thereof.

BUSINESS NAMES

27. Within 30 days after the execution of this Stipulation, the Plaintiffs shall cease using the "Anna Bove" name or any variation thereof or any other confusingly similar name or trademark in connection with any business activities. All references to "Anna Bove" or any variation thereof shall be removed from the domain names, websites and products under Plaintiffs' control.

28. Within 30 days after the execution of this Stipulation, the Defendants and State Action Defendants shall cease using the "ABC" name, (including, without limitation, any name or trademark that includes "ABC" or any other confusingly similar name or trademark in connection with any embroidery business activities. All other references to the name "ABC" or any variation thereof shall be removed from the domain names, website names and product names in embroidery business under Defendants' and State Action Defendants' control.

DOMAIN NAMES

29. Within forty five (45) days after the execution of this Stipulation, the Defendants shall undertake all reasonable

steps and execute all documents necessary to transfer www.abc-embroidery-designs.com and www.abc-cross-stitch-patterns.com ("ABC Domain Names"), free and clear from any charges, encumbrances, liens or other security interests, to Plaintiffs.

30. Within forty five (45) days after execution of this Stipulation, the Plaintiffs shall undertake all reasonable steps and execute all documents necessary to transfer www.annabovcollections.com, www.annabovcollection.com, and www.annabov.com ("Anna Bove Domain Names") free and clear from any charges, encumbrances, liens or other security interests, to Defendants.

JOINT STATEMENT

31. Within ten (10) days after the execution of this Stipulation, the parties shall send the following joint statement to the last known e-mail addresses of Viveka Berg, Bobbi Barry, Gale Hutte and Pam _____:

Dear _____:

We are writing to inform you that the dispute between us has been amicably resolved. From now on, we invite you to visit Anna Bove embroidery at _____ and the ABC embroidery designs at _____. We sincerely hope that Anna Bove embroidery and ABC embroidery will continue to engage in mutually beneficial business dealings with you in the future.

32. None of the Parties shall communicate anything to the above individuals in contravention of the above statement.

EBAY STORE

33. Within ten (10) days after the execution of this Stipulation, the Defendants shall contact eBay and withdraw their complaint regarding eBay store known as "polyadolgin2" and/or "abc-machine-embroidery" (the "eBay Store"), pursuant to the Complaint Withdrawal and Account Assignment, a form of which is annexed hereto as Exhibit F. The Defendants shall thereafter undertake all reasonable steps and execute all documents necessary to reinstate the eBay Store to Plaintiffs' control, including, but not limited to, paying any charges assessed in connection with reinstating the eBay Store.

34. Upon the transfer of the eBay Store to their control, the Plaintiffs shall cease using the "Polina Dolginov" name or any variation thereof in connection with the eBay Store. The Parties acknowledge that Plaintiffs may not be able to remove all references to such name from the eBay administration section/documents for the eBay Store, and that such non-removal shall not be a violation of this Stipulation.

SANCTIONS AWARD AND OTHER REMEDIES

35. Upon the execution of this Stipulation, Plaintiffs agree that Defendants' obligation to Plaintiffs in connection with the payment of \$42,034.08 (the "Award") awarded pursuant to the Opinion and Order dated September 28, 2011 of Judge Allyne R. Ross (the "O&O") shall be deemed to be fully satisfied.

36. In the event that the Defendants breach any material provision of this Stipulation at any time and fail to cure such breach within thirty (30) days from the written notice from the Plaintiffs of such breach, then the Award shall be reinstated and that Defendants shall be liable, severally and jointly liable, for the payment of same, plus post-Judgment interest of 9% per year from the date of execution of this Stipulation, up to \$75,000.00, or, at Plaintiffs' sole election and discretion, for actual damages suffered by Plaintiffs.

37. PD shall not be liable under Paragraph 36 above, in the event that she has not breached the Stipulation and is not in business, in any capacity, with any of the other Defendants or AS, in connection with operating a business which deals with embroidery supplies or designs.

38. The successful party in any litigation initiated in connection with any alleged breach hereunder shall recover its reasonable legal fees and costs.

39. Prior to any Party herein acting on an alleged uncured breach, the Parties shall attempt to resolve the alleged breach by engaging in a two week negotiation, mediation or other alternative resolution procedure. This two week period shall begin with receipt of the notice of breach by the allegedly breaching party and shall run concurrently with the thirty (30) day cure period set forth above in Paragraph 36.

DISMISSAL OF ACTIONS

40. Within ten (10) days of the execution of this Stipulation, the Federal Action shall be dismissed in its entirety, with prejudice and without an award of fees or costs as to any party, except that the Court shall retain personal and subject matter jurisdiction of this matter for the purpose of enforcing the terms of this Stipulation. Any action or proceeding to enforce this Stipulation may be brought before the Court without the commencement of a separate action or proceeding.

41. Within ten (10) days of the execution of this Stipulation, the State Action shall be dismissed in its entirety, with prejudice and without an award of fees or costs as to any party, except that the Court shall retain personal and subject matter jurisdiction of this matter for the purpose of enforcing the terms of this Stipulation. Any action or

proceeding to enforce this Stipulation may be brought before the Court without the commencement of a separate action or proceeding.

NON-DISPARAGEMENT

42. The Parties shall not make and will not cause to be made after the entry of this Stipulation: (i) any public and/or any written statements, observations or opinions that disparage or harm the reputation of the others to anyone; and/or (ii) any statements, observations or opinions that disparage or harm the reputation of the others, whether written or oral, public or private, to customers or prospective customers who may be interested in purchasing embroidery designs or supplies.

43. MUTUAL RELEASES

46. The Defendants and State Action Defendants hereby release any and all claims against the Plaintiffs (and each of its officers, directors, partners, shareholders, affiliates, subsidiaries, agents, attorneys, employees, controlled corporations or entities, predecessors, successors and assigns) whether presently known or unknown, which the Defendants and/or its successors or assigns ever had, now have or hereafter can,

shall or may have for, upon or by reason of any matter, cause or thing whatsoever from the beginning of time through the date of the execution of this Stipulation. It is the intention of the Defendants to hereby fully, finally and forever settle and release all disputes and differences, known or unknown, suspected and unsuspected, which now exist, may exist, or heretofore have existed between the Defendants, on the one hand, and the Plaintiffs on the other.

47. The Plaintiffs hereby release any and all claims against the Defendants and State Action Defendants (and each of their officers, directors, partners, shareholders, affiliates, subsidiaries, agents, attorneys, employees, controlled corporations or entities, predecessors, successors and assigns) whether presently known or unknown, which the Plaintiffs and/or its successors or assigns ever had, now have or hereafter can, shall or may have for, upon or by reason of any matter, cause or thing whatsoever from the beginning of time through the date of the execution of this Stipulation. It is the intention of the Plaintiffs to hereby fully, finally and forever settle and release all disputes and differences, known or unknown, suspected and unsuspected, which now exist, may exist, or heretofore have existed between the Plaintiffs, on the one hand, and the Defendants and State Action Defendants on the other hand.

MISCELLANEOUS

48. The Parties acknowledge that the terms of this Stipulation are the product of mutual negotiations and compromise between them. The Parties further acknowledge that they have entered into this Stipulation freely and voluntarily and that the meaning, effect and terms of this Stipulation are fully understood by them. As such, the Parties further represent and warrant that they shall have no grounds to challenge, set aside or void this Stipulation on grounds of fraud, fraudulent inducement or related legal theories.

49. The parties acknowledge that they have entered into this Stipulation freely and voluntarily and that the meaning, effect and terms of this Stipulation have been fully explained to them by their respective counsel, Peter L. Berger, Esq. of Levisohn Berger, LLP and Roman Leonov, Esq. of the VaLe Law Group, P.C. for the Defendants and State Action Defendants, and Eric Wertheim, Esq. and Daniel Akselrod, Esq. of Val Mandel, P.C. for the Plaintiffs.

50. This Stipulation constitutes the entire agreement between the Parties with respect to the subject matter of this Stipulation and supersedes any prior agreements and understandings with respect to such subject matter. This Stipulation may be changed, waived, modified or terminated only

by a written instrument signed by both Parties to this Stipulation.

51. This Stipulation shall be governed by, and construed in accordance with, the laws of the State of New York, without giving effect to applicable principles of conflicts of law to the extent that the application of the laws of another jurisdiction would be required thereby.

52. The parties hereto shall be deemed to have accepted service of process of summons and complaint, summons with notice, or any other papers, filed in a legal action arising in connection with, or out of, any breach, or any controversy or claim of breach of any terms of this Stipulation, as good and proper service under the laws of the State of New York, if any such papers are delivered to them via certified mail, return receipt requested, or registered mail or any nationally recognized courier, to the address set forth in paragraph 56 below.

53. 55. 
