 Suspension of Library Privileges

Dear Mr. Brinn:

We are attorneys representing the Syosset Public Library.

Please be advised that the Syosset Public Library Director, Judith Lockman, has suspended your privileges to enter upon Library premises and borrow Library materials until October 15, 2008.

The suspension of your privileges as aforesaid is the result of your improper conduct on September 29, 2007, August 25, 2007, August 18, 2007 and July 14, 2007. Your improper conduct included the following:

You disrupted Library operations on September 29, 2007 when you inappropriately followed a particular Library Page employee throughout the Library building and interfered in the particular Library Page employee's performance of duties in returning books to shelves.

You disrupted Library operations on August 25, 2007 when you continuously walked throughout the public area of the Library building in a visibly agitated manner, while loudly uttering various statements in a strident and harsh tone; and which conduct disrupted Library operations and the interfered in Library patrons' quiet use and enjoyment of the Library.

You disrupted Library operations on August 18, 2007 when you continuously paced the Library's public area adjacent to the main floor media department in a visibly agitated manner, while loudly uttering various statements in a strident and harsh tone; and which conduct disrupted Library operations and the interfered in Library patrons' quiet use and enjoyment of the Library.

You disrupted Library operations on July 14, 2007 when you continuously paced the Library's public area adjacent to the main floor media department in a visibly agitated manner, while loudly uttering various statements in a strident and harsh tone; and which conduct disrupted Library operations and the interfered in Library patrons' quiet use and enjoyment of the Library.

Be advised that you have the right to protest the suspension of your privileges to the Library Board of Trustees, or its designee. We enclose a copy of the Library's Policy of Maintenance of Public Order at Library Premises which sets forth the Appeal process.


Be further advised that the Library Board of Trustees reserves its rights with respect to exercising reasonable control over the Library Facilities pursuant to Law and Library Policy.

Be further advised that your entry into the Library Building or upon Library premises prior to October 15, 2008 shall subject you to immediate ejection from the premises as a trespasser. Moreover, your trespass upon Library premises during the period up through October 15, 2008 may result in your immediate arrest.

Finally, all materials borrowed by you from the Syosset Public Library should be returned to the Plainview-Old Bethpage Public Library.
