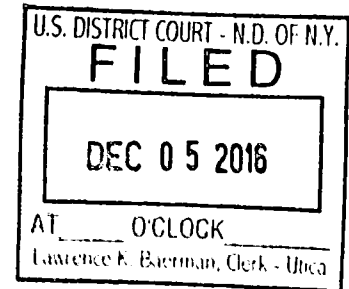


**STIPULATED DISMISSAL**
