

Scheindlin, United States District Judge, and the Court, on December 31, 2015, having rendered its Memorandum Opinion and Order granting the request for a 54(b) final judgment, that there is no just reason for delay, directing the Clerk of Court to enter final judgment for Trauber Oil Company and close these motions (07 Civ. 10470, Dkt. No. 652; 14 Civ. 01014, Dkt. No. 176), it is,

ORDERED, ADJUDGED AND DECREED: That for the reasons stated in the Court's Memorandum Opinion and Order dated December 31, 2015, the request for a 54(b) final Judgment is granted, there is no just reason for delay, pursuant to Fed. R. Civ. 54(b), judgment is entered for Trauber Oil Company in 07 Civ. 10470 and 14 Civ. 01014.
