**ORDER TO ALLOW MULTIMEDIA
EQUIPMENT AND TRIAL MATERIALS
INTO COURTROOM 21C**

Upon the joint request of Plaintiffs and Defendants (the "Parties") to allow multimedia equipment and trial materials into Courtroom 21C of the Patrick Moynihan United States Courthouse, it is ordered that:

1. Counsel for the Parties and their respective technology coordinators shall be permitted to bring into the Patrick Moynihan United States Courthouse, from Friday, November 9, 2007, through the conclusion of trial, currently scheduled for Wednesday November 21, 2007, certain multimedia equipment (the "Equipment"). The Equipment may include the following:

- eight (8) monitors (1 for the Court, 1 for the witness, 1 for the Court's law clerk, 4 for the Parties' counsel, 1 for the technology coordinators);
- two (2) two-port VGA splitters;
- one (1) elmo;
- two (2) switcher boxes;
- seven (7) laptop computers;

- five (5) external hard drives;
- three (3) mice;
- four (4) flash drives;
- two (2) printers; and
- any necessary cables and power cords.

2. Counsel for the Parties shall be permitted to bring into the Patrick Moynihan United States Courthouse, from Friday, November 9, 2007, through the conclusion of trial, currently scheduled for Wednesday November 21, 2007, boxes containing production documents, deposition transcripts, trial exhibits and other litigation materials.


3. Counsel for the Parties and their technology coordinators shall be permitted entry to Courtroom 21C on Friday November 9, 2007, to set up and test the above-referenced Equipment. *Parties will have courtroom access between 9 AM + 5 pm.*

4. Counsel for the Parties and their technology coordinators shall be permitted to bring in and out of the Courthouse at all times during the trial any or all of the Equipment. *Parties will have courtroom access Monday thru Friday from 9 AM to 5 PM.*


