I, ADAM J. RAPPAPORT, pursuant to 28 U.S.C. § 1746, do hereby declare:

- 1. I am an attorney associated with the firm of Levine Sullivan Koch & Schulz, L.L.P., attorneys for plaintiff Associated Press ("AP"). I submit this declaration in support of AP's opposition to defendant's motion for summary judgment and AP's cross-motion for summary judgment in its favor.
- 2. At issue in the lawsuit are requests submitted by AP to the Department of Defense ("DOD") seeking information pursuant to the Freedom of Information Act ("FOIA"). AP's requests were dated November 16, 2004 and January 18, 2005. (True and correct copies of these requests are submitted herewith as Exhibits A and B, respectively.)
- 3. After this litigation was initiated in June 2005, DOD produced documents in response to these AP requests, but the documents were heavily redacted.
- 4. AP does not now seek to compel the release of information withheld by DOD on grounds of national security under Exemption 1, because information is classified and therefore within Exemption 3, or the identities of DOD personnel withheld on privacy grounds pursuant to Exemption 6.
