My name is Karl-Heinz Remmers, and I am CEO of the Solarpraxis AG, a book publisher located in Berlin Germany. Solarpraxis AG is a member of the settlement class embraced by the proposed settlement agreement that is before this Court in this action (the "Settlement Agreement"), because it owns rights in books that are protected by U.S. copyright law. We write to object to the Settlement Agreement.
