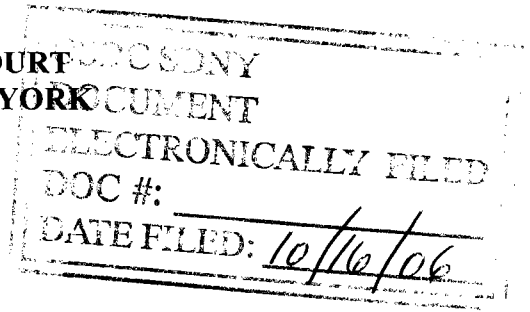

WHEREAS in the event that Plaintiffs/Counterclaim Defendants respond to the Counterclaim by moving, the parties wish to establish a briefing schedule;


IT IS HEREBY STIPULATED AND AGREED by and among the undersigned counsel for all parties that the time for Plaintiffs/Counterclaim Defendants to


