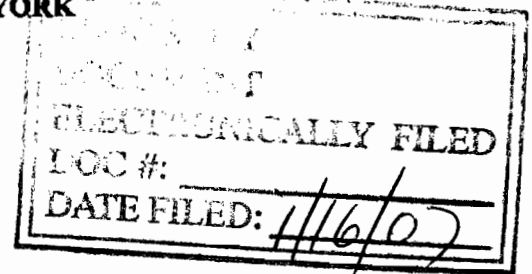

WHEREAS, on November 17, 2006, Defendants/Counterclaim Plaintiffs filed a First Amended Counterclaim;

WHEREAS, the original deadline for Plaintiffs/Counterclaim Defendants to move, answer or otherwise respond to the First Amended Counterclaim was December 4, 2006;

WHEREAS, the Court previously granted the parties' request for a briefing schedule for Plaintiffs/Counterclaim Defendants' motion to dismiss Defendants/Counterclaim Plaintiffs' First Amended Counterclaim, pursuant to which Plaintiffs/Counterclaim Defendants' time to move, answer or otherwise respond to the First Amended Counterclaim was extended through and including December 11, 2006;

WHEREAS, that briefing schedule also provided that the deadline to file and serve any opposition brief was January 15, 2007, and that the deadline to file and serve a reply would be February 12, 2007;

WHEREAS, on December 11, 2006, Plaintiffs/Counterclaim Defendants filed a Motion to Dismiss Defendants/Counterclaim Plaintiffs' First Amended Counterclaim;


WHEREAS, the parties seek a short extension to file their respective opposition brief and reply; and

WHEREAS, this is the first such extension;

IT IS HEREBY STIPULATED AND AGREED by and among the undersigned counsel for all parties that the deadline for Defendants/Counterclaim Plaintiffs to serve and file an opposition brief will be January 18, 2007, and the deadline for Plaintiffs/Counterclaim Defendants to serve and file a reply brief will be February 15, 2007.


