2. In March 2008, I accessed the website <http://www.download.com> to download the LimeWire software. I took all the steps necessary to download the LimeWire

software from this website. No dialog box appeared that required me not to use the LimeWire software for copyright infringement. I printed out screenshots of all the steps necessary to download the LimeWire software from this website. Plaintiffs' Ex. 329 (submitted on September 26, 2008) is a true and correct copy of these screenshots.

3. On September 7, 2008, I accessed the website <http://www.gnutelliums.com> to download the LimeWire software. I was redirected to the website <http://files.filefront.com/LimeWire+Windows+v426/3760359/fileinfo.html>. I took all the steps necessary to download the LimeWire software from this website. No dialog box appeared that required me not to use the LimeWire software for copyright infringement. I printed out screenshots of all the steps necessary to download the LimeWire software from this website. Plaintiffs' Ex. 330 (submitted on September 26, 2008) is a true and correct copy of these screenshots.

4. On September 23, 2008, I accessed the website <http://theslip.nin.com>. Plaintiffs' Ex. 371 (submitted on September 26, 2008) contains a true and correct copy of a printout from this website. After registering my name and e-mail address on this website I received an e-mail containing a link. Upon clicking on this link I was able to download various song recordings and in particular the song "Head Down", without having to install or use the LimeWire software.

5. On September 23, 2008, I accessed the website [http://stash.nugs.net/wsp/0010nola\\_mp3.asp?artist=6&show=48&cmd=shows](http://stash.nugs.net/wsp/0010nola_mp3.asp?artist=6&show=48&cmd=shows). Plaintiffs' Ex. 373 (submitted on September 26, 2008) contains a true and correct copy of a printout from this website. I was able to download the song "Ride Me High" directly from this website, without having to install or use the LimeWire software.

6. On August 27, 2008, I accessed the website <http://www.vidablue.net/multimedia>. Plaintiffs' Ex. 374 (submitted on September 26, 2008) consists of a true and correct copy of a printout from this website. I found that the song "Most Events Aren't Planned" is available directly from this website, without having to install or use the LimeWire software.

7. On September 4, 2008, I accessed the website <http://stash.nugs.net/stash.asp?cmd=dl&artist=-1>. Plaintiffs' Ex. 375 (submitted on September 26, 2008) consists of a true and correct copy of a printout from this website. I was able to download the song "Most Events Aren't Planned" directly from the Nugs.net website, without having to install or use the LimeWire software.

I declare under penalty of perjury that the above is true and correct.
