UNOPPOSED MOTION FOR WITHDRAWAL OF COUNSEL

Pursuant to Local Civil Rule 1.4, Plaintiffs Arista Records LLC; Atlantic Recording Corporation; BMG Music; Capitol Records, Inc.; Elektra Entertainment Group Inc.; Interscope Records; LaFace Records LLC; Motown Record Company, L.P.; Priority Records LLC; Sony BMG Music Entertainment; UMG Recordings, Inc.; Virgin Records America, Inc.; and Warner Bros. Records Inc. ("Plaintiffs") respectfully submit this unopposed motion to allow the withdrawal of Plaintiffs' lead counsel of record as set forth below. In support of this motion, Plaintiffs, through the undersigned counsel, state as follows:

1. Plaintiffs' lead counsel in this action has been the law firm of Cravath, Swaine & Moore LLP ("Cravath"). Plaintiffs and Cravath have agreed that Cravath should be allowed to withdraw as counsel of record for Plaintiffs. The law firm of Munger, Tolles & Olson LLP has

- 4. Plaintiffs, through their counsel, have communicated to counsel for Defendants their intention to move for the withdrawal of counsel set forth herein. Defendants' counsel stated that Defendants do not oppose this motion.
