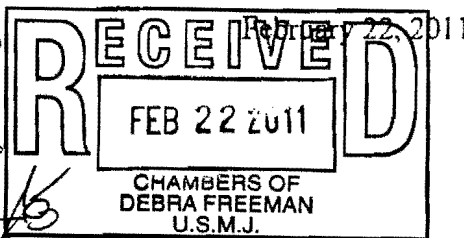

Dear Judge Freeman:

In response to the Court's February 16, 2011 Order, the parties have reached an agreement for the schedule to "produce documents sufficient to show any release of a song at issue in this action as a single, prior to the inclusion of that song as part of an album or any other compilation or groups of sound recordings." (Order at 3). Plaintiffs have agreed with Defendants to substantially complete their production by February 28 for at least two, and perhaps three, of the Plaintiffs. The remainder of Plaintiffs' production will be made during the week of February 28, with an outside date of Friday, March 4.

The within production schedule is approved, but nothing herein is intended to alter the briefing schedule set by Judge word.
