Re: *RIAA, et al. v. Lime Wire LLC, et al.*

Counsel:

I write regarding several documents that Defendants apparently have withheld under a claim of privilege.¹ Each of the following entries on Lime Wire's privilege log, July 8, 2008, was shared with one or more individuals from companies other than the Lime Wire entities, including without limitation individuals from Bearshare (*e.g.*, Vinnie Falco), Sharecom (*e.g.*, Mike Weiss), Freepeers (*e.g.*, Vinnie Falco), Morpheus (*e.g.*, Matt Neco), and Flanigan Consulting (*e.g.*, Adam Eisgrau), and/or were circulated on public or semi-public email lists, including "eff-ip." We fail to see how any such communications would have been privileged in the first place, or, if there was a claim of privilege, why that claim would not have been waived when the communications were shared with third parties.


