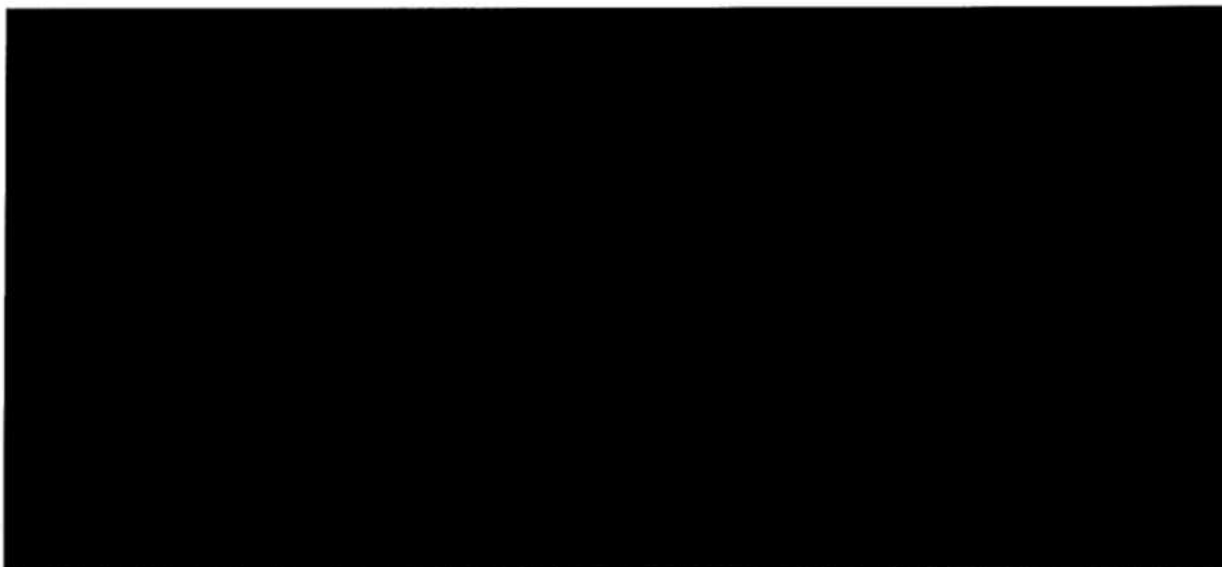

PRECLUDE CERTAIN PURPORTED EXPERT TESTIMONY BY GEORGE STRONG**

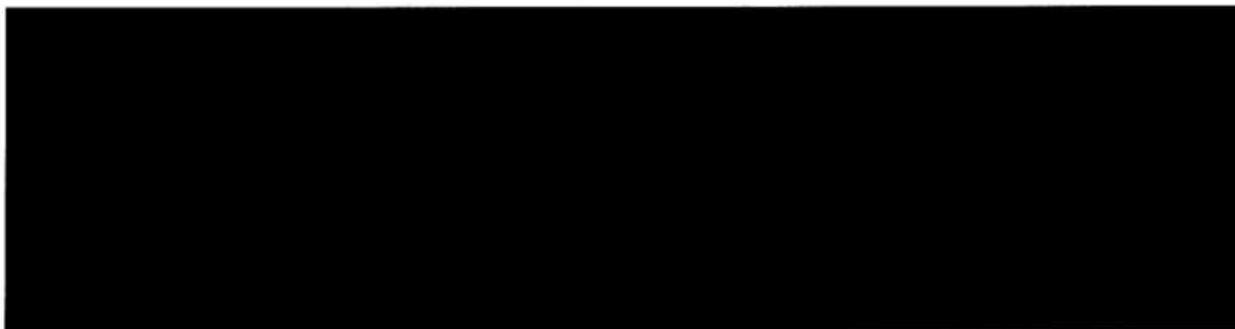
I, Tariq Mundiya, declare as follows:


