WHEREAS, the parties agree that Defendants have in their possession certain video files that may contain information responsive to Plaintiffs' First Request for the Production of Documents and Access to Equipment and Facilities;

WHEREAS, defense counsel has provided a list of the names of these files to plaintiffs' counsel and indicated that defense counsel has no knowledge regarding the content of these files;

WHEREAS defense counsel has also indicated that the titles of some of the files lead them to believe that the files could contain pornographic and/or illicit content;

WHEREAS Defendants do not oppose the production of these files for review by plaintiffs' counsel, but yet they wish to do so under Court order;

WHEREAS, plaintiffs' counsel, having reviewed a list of the names of these files provided by defense counsel, have requested that the Defendants provide Plaintiffs with copies of the files listed in Exhibit A (which is a subset of all the video files on the list);

WHEREAS, the Defendants, out of concern over potential illicit content within these files, in an abundance of caution, have declined to provide these files to Plaintiffs in the absence of an Order by this Court;


WHEREAS, the Defendants do not oppose the entry of an Order by this Court requiring Defendants to provide these files to Plaintiffs;

IT IS HEREBY STIPULATED AND AGREED by and among the undersigned counsel for all parties that upon this Order by this Court, Defendants shall produce to the Plaintiffs true and correct copies of the video files listed in Exhibit A by federal express.


