proceedings against him in any State or Federal court.






CLIFFORD THAU, being duly sworn, states as follows:

WHEREFORE it is respectfully requested that the motion to admit Michael D. Marin, pro hac vice, to represent Defendants in the above-captioned matter be granted.



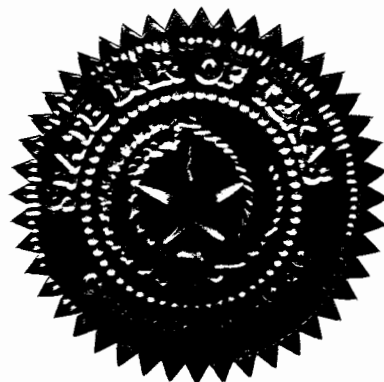
