

DOUGLAS H. WIGDOR, an attorney admitted in the United States District Court for the Southern District of New York, hereby affirms under penalty of perjury:


1. I am a partner in the law firm of Thompson Wigdor & Gilly LLP, and am acting as local counsel for Plaintiffs in the above-captioned action.


