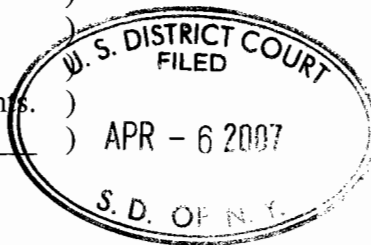

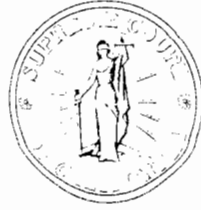


I, William Hohengarten, being duly sworn, hereby depose and say as follows:




