Digital clip rights belong to CBS, and actually are included in the definition of merchandising rights, along with games, wireless applications and new media platforms. (There is, as I noted, a limited exception for licensing clips into motion pictures, tv shows and print publications.) CBS also retains rights for "Made for New Media" productions, which envisions content not created for initial distribution via theatrical, DTV or TV. So to summarize: Paramount does not have the merchandising and clip licensing rights that we need.

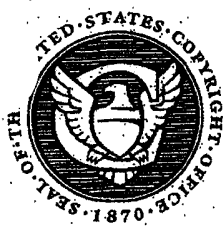
