Dear Jennifer,

Thank you for your notification regarding content owned by Yahoo! Music.

YouTube takes the rights of intellectual property owners seriously, and complies as a service provider with all provisions of the Digital Millennium Copyright Act ("DMCA"). Your name will be listed on each of the videos as the notifying party of the infringement. We would not want that listed on content that you do not own.

Please respond with specific links to the infringing video(s). The links can be found in the address bar or in the info box labeled "URL" while the video is playing. Once we have these links we will remove the videos in question promptly.
