

Dear Michael,

I write in response to your May 1, 2009 letter. As your letter concedes, we have already produced several thousand emails sent or received by Ms. Tipton, who left Viacom's employment in September 2007. Defendants never identified Ms. Tipton as a priority custodian and first identified her as an additional custodian on January 28, 2009, almost two years after Viacom's lawsuit was filed and almost a year and a half after Ms. Tipton left Viacom's employment. Viacom had no reason to know that her documents would be relevant in the Viacom action at the time she left, and Defendants' recent fishing expedition into Paramount's marketing activities does not alter that fact. In any event, Defendants have sought documents from numerous individuals who worked with Ms. Tipton, and have obtained thousands of emails to and from her. Defendants simply cannot claim any prejudice and have not done so. And, as you know, Defendants remain free to depose Ms. Tipton and examine her on the thousands of her email communications that Viacom has produced.
