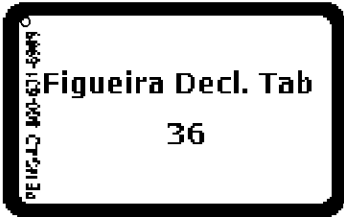

Q. Can you summarize for me the nature of the discussions that occurred with YouTube?

A. Yes. I engaged outside counsel to assist me with sending notice and takedown letters to YouTube pursuant to, I believe, an E-mail exchange subsequent to that notice and takedown letter. 60,000 copyrights. I gave him names of certain of the clients within our catalog. I told him we were willing and eager to engage in a strategic alliance, and that I would welcome any proposal YouTube wanted to make, and I would consider any proposal that YouTube wanted to make. I was summarily told that YouTube had no interest in Cherry Lane given its small market share.

Q. Was there any other information -- sorry, was there any other issues discussed during the course of that conversation?

A. Mr. Maxcy's response that Cherry Lane's market share was too small to be considered and that made it pretty clear where we stood. I don't believe we got into any other additional issues or topics of discussion.
