4 screen shot of the video looks like a time code. Looks  
5 like "01:18:18:03." 11:55

6 A. Yes.

7 Q. Do you know why those numbers were superimposed  
8 on the video like that?

10 Q. Was including a time code in the video 11:55  
11 something that MTV ever asked Fanscape to do?

12 A. I don't know.

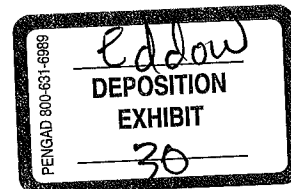

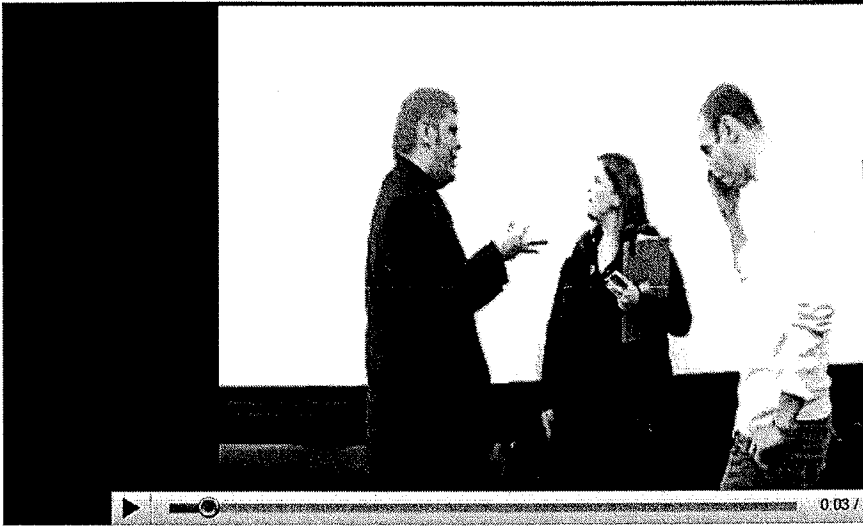

The character is referred to in the movie by his last name, so there's a lot of talk about "Davian." It's a nice inside joke.

It's hard to say whether Paramount has authorized these clips as a way of stoking interest in the \$200 million film (that includes promotion), or if some snarky person in the production office is behind the leaks.

And if there are two today, are more coming? The answer is probably yes. Paramount's mission, if they choose to accept it, may be to stem the tide in coming days.

The clips can be found on youtube simply by typing in Cruise's name or the name of the movie in the search engine.

But be warned: you will also find several parodies of the film and of Cruise himself regarding Katie Holmes and Scientology. They are almost more fun to watch than the clips.

In this case, we uploaded clips for 'Blowin Up' in July of 2006. The clips were from MTV/Viacom. At that time, Warner Bros gave us the clips and full rights to distribute. This was before the recent decision from MTV that videos were no longer to be available on YouTube.

Since that decision, NO videos have been uploaded that compromise that policy, hence no intentional infringement. This is an old video, put up BEFORE that policy was instituted, and that is the reason it was overlooked and not taken down. It is a mistake of circumstance, not malicious intent.

Please let me know what I need to do to re-instate my account and videos (minus Jamie Kennedy, of course), or at least re-use my user name (for people who use that as name recognition). We have tons of subscribers and CLIENTS that depend on us to promote their artists. YouTube is one of the best and it could greatly hinder the online success our clients expect for their artists. This could also negatively reflect on YouTube, as we deal with Universal Records, Warner Bros Records, Hollywood Records, Island/Def Jam Records, Virgin/EMI Records, Sony Records and more on a regular basis.
