Dear Claims Administrator:

We are in receipt of your letter dated November 1, 2011, indicating the Charles G Koch 1997 Trust's request for exclusion (dated October 26, 2011) is not valid.

It would take considerable time and expense to research company records to compile the information you state is required in order to be excluded from the settlement. We believe the opportunity costs of such an undertaking would exceed the value of any potential claim. On that basis, Koch does not wish to participate in this class action settlement matter and therefore requests exclusion from the Class on behalf of the Charles G. Koch 1997 Trust and any other trust or entity related to Charles G. Koch and his immediate family as well as Koch Industries, Inc or any affiliated company

It is Koch's right to make an election to be excluded from this settlement matter, irrespective of whether or not class plaintiffs believe that Koch made any exchanges of the subject security during the class period. Rule 23 of the Federal Rules of Civil Procedure plainly states "that court will exclude from the class any member who requests exclusion" F R C P 23 (c)(2)(v).

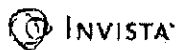

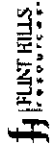

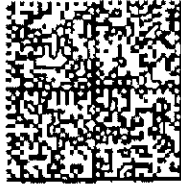
