

Dear Judge Marrero:

I write on behalf of my client, PricewaterhouseCoopers LLP ("PwC Canada"), defendant PricewaterhouseCoopers Accountants N.V. ("PwC Netherlands") (collectively, the "PwC Defendants"), and the Plaintiffs (together with the PwC Defendants, "the Parties") to ask the Court to approve a slight modification to the current schedule for the Parties' pre-trial submissions.

The current schedule, entered by an August 28, 2015 endorsement of my prior letter of August 26, 2015, Docket No. 1406, provicled for the submission of the items listed in the Court's standing requirements on pre-trial filings on November 2, 2015.

The Parties have exchanged drafts of these items with each other and engaged in multiple conferences to reach agreement on as much of this material as possible and identify any areas of disagreement and present those to the Court for resolution. The Parties are of the view that a short extension of the deadline for submitting this material to the Court will allow them to resolve additional issues and present feewer issues to the Court for resolution without any negative impact on the overall schedule.

The Parties therefore ask the Court to allow them to make their joint pre-trial submission of all items required except for the exhibit list on or before November 13, 2015, and to submit the exhibit list on or before November 20, 2015. The schedule for motions in limine (motions due November 2, 2015, responses 14 days thereafter, and replies seven days after responses) shall remain unchanged, and the case will still be ready for a Final Pre-Trial Conference as of December 1, 2015 as currently planned.
