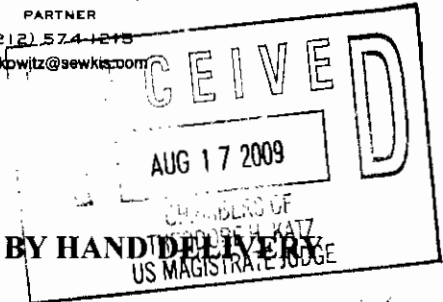

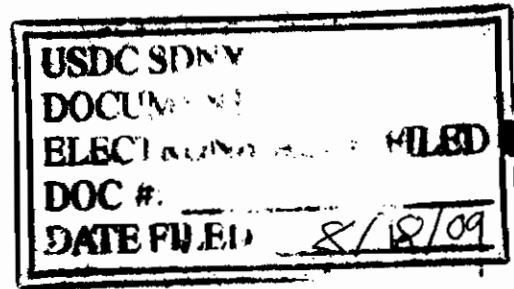

Dear Judge Katz:

We write regarding Fairfield Sentry Limited's (the "Company") motion to remand this action back to New York State Supreme Court, which was filed and served on July 10, 2009. *Anwar*, Docket No. 181. On July 27, 2009, Defendant Fairfield Greenwich Advisors LLC ("FGA") served and filed its opposition papers (*Anwar*, Docket No. 195) and the Company's reply papers are currently due on August 21, 2009.

On July 21, 2009, the Court held a telephone conference to discuss matters relating to the remand motions. That same day, the British Virgin Islands High Court entered an order granting an application for the liquidation of the Company and appointing Christopher Stride and Kenneth Kryss of Kryss Associates as the joint liquidators of the Company (the "Joint Liquidators").<sup>1</sup> Attached is a copy of the BVI Order. The Joint Liquidators are in the process of formally retaining new U.S. counsel who will handle the Company's reply papers and other legal matters. Seward & Kissel LLP will be withdrawing as counsel for the Company.




