This confirms our conversation earlier today that Simpson Thacher has accepted service of the *Zohar* complaint on behalf of its clients Fairfield Greenwich Advisors LLC, Fairfield Greenwich (Bermuda) Ltd., and Fairfield Greenwich Limited, sent by Federal Express on June 22, 2009 with accompanying documents (*i.e.*, Notice of Lawsuit and Request for Waiver of Service of Summons, with the complaint filed in *Zohar* attached; two copies of the Waiver of Service of Summons, with a self-addressed FedEx envelope for you to return the executed copy of the Waiver of Service of Summons; a copy of the Electronic Case Filing Rules & Instruction; and a copy of the Individual Practices of United States District Judge Victor Marrero.)
