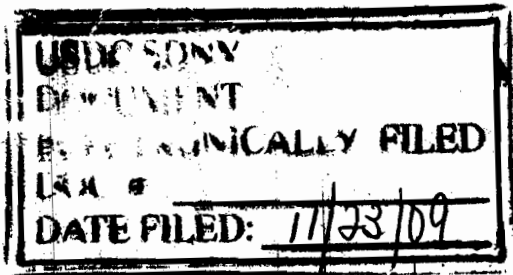

WHEREAS, the SCAC names PricewaterhouseCoopers Accountants Netherlands N.V. ("PwC Netherlands") as a defendant;


