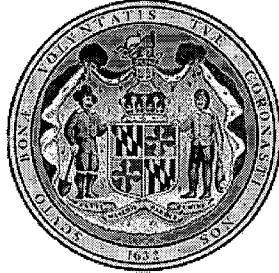


Marcus Green , being duly sworn, hereby deposes and says as follows:

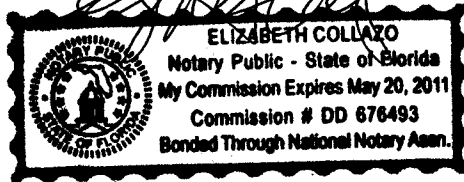
