

David A. Barrett, under penalty of perjury, hereby declares:

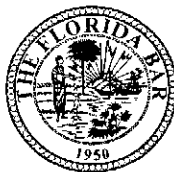


