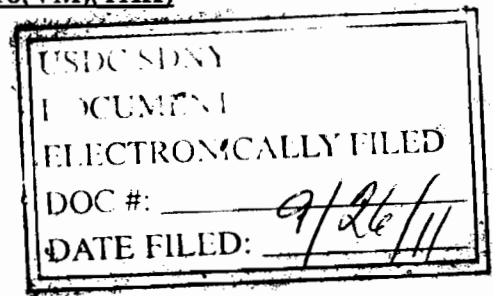

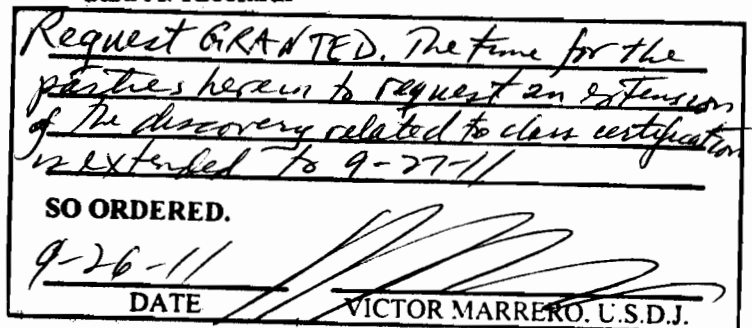
Dear Judge Katz:
