
I write on behalf of Standard Chartered in connection with discovery in the above-captioned action. Plaintiffs have requested that Standard Chartered provide contact information for each of the individuals who appear on documents the Bank has produced related to Fairfield due diligence. Standard Chartered, however, has no record of many of the names on plaintiffs' list, many of whom appear on documents from 2006 or earlier and may therefore have been American Express employees. Magistrate Judge Katz, at plaintiffs' suggestion, has asked that Standard Chartered request contact information from American Express for the attached list of individuals whom the Bank has been unable to locate in its records. For many of the individuals, plaintiffs provided us with only a first initial and last name. Where possible, we have tried to determine the first name of the individuals based on a review of our documents. The first names that are listed in parenthesis are our best guess as to whom the plaintiffs are referring to, but we cannot say with certainty that these are the correct first names.
