**STIPULATION AND PROPOSED ORDER  
REGARDING ADDITIONAL NAMED PLAINTIFFS**

WHEREAS, Plaintiffs and the putative class are represented by the undersigned Interim Co-Lead Counsel and Counsel for the PSLRA Lead Plaintiffs ("Co-Lead Counsel"), pursuant to the Court's January 30, 2009, and July 7, 2009 Orders;

WHEREAS, Defendants are represented by the undersigned counsel;

WHEREAS, Co-Lead Counsel have informed Defendants that certain individuals and entities with claims related to those pleaded in the Second Consolidated Complaint ("SCAC") filed September 29, 2009 wish to be included in this action as named plaintiffs ("Additional Named Plaintiffs"), and considered parties to this action to the same extent as if they had been named originally as Plaintiffs in the SCAC;

WHEREAS, the Court's March 11, 2009 Order requires joinder of additional parties before the deadline for Plaintiffs to file a motion for class certification;

NOW, THEREFORE, the parties stipulate and agree as follows:

1. Plaintiffs shall, from time to time, submit to Defendants proposed Appendices listing Additional Named Plaintiffs who wish to be added as parties to this Action, in lieu of such plaintiffs filing new related proceedings in their individual names against Defendants.

2. In each such Appendix, Co-Lead Counsel shall provide for each Additional Named Plaintiff the same information that was provided for Plaintiffs named in the SCAC, specifically including: investor name; place of residence of individual; place of incorporation of entity and type of entity, if applicable; fund invested in; date of original investment; and dates of any subsequent investments.

3. Within fourteen (14) business days of receiving such proposed Appendix, Defendants shall inform Co-Lead Counsel: (a) whether they consent to the addition to this Action of each Additional Named Plaintiff, which consent shall not be unreasonably withheld, and (b) if consent is withheld, the reasons consent was withheld for any such Additional Named Plaintiff.

4. The Additional Named Plaintiffs to which Defendants have consented, as set forth above, or to which Defendants have not responded within fourteen (14) business days, shall be deemed added to this Action as parties as of the date of filing and service by Co-Lead Counsel of the Appendix identifying such Additional Named Plaintiffs.

5. Other than for purposes of any applicable statute of limitations, Additional Named Plaintiffs shall be deemed parties to this Action to the same extent as if they had been named as plaintiffs in the SCAC, including without limitation:

a. All motions filed and orders issued shall apply to the claims of Additional Named Plaintiffs as if they had been named as plaintiffs in the SCAC.

b. Additional Named Plaintiffs will be subject to discovery to the same extent as if they had been named as plaintiffs in the SCAC.

6. The inclusion of Additional Named Plaintiffs shall not have any impact on the Court's existing scheduling orders governing this Action.

7. Co-Lead Counsel reserve the right to seek Court approval for the addition of any Additional Named Plaintiffs for which Defendants have withheld their consent under paragraph 3 above.

8. By agreeing to this Stipulation, Defendants do not waive and expressly preserve any and all defenses that they may have, including without limitation defenses to the claims of the Additional Named Plaintiffs and the suitability of any plaintiff, including any Additional Named Plaintiff, to serve as a representative of any class certified in this Action.

9. By agreeing to this Stipulation, Plaintiffs do not waive and expressly preserve all rights that they may have to seek to: (a) add parties to this Action, (b) amend the complaint in this Action, or (c) file new actions alleging the same or similar claims against Defendants.

10. The authorization for Plaintiffs to use the procedure set forth in this Stipulation and Order shall terminate on the date set by the Court for Plaintiffs to file a motion for class certification.
