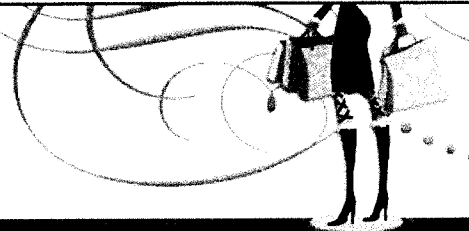

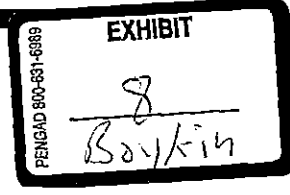

- We only one method of shipping, USPS Mail
- We ship worldwide
- Shipment is available and only to credit card billing address only.
- All Shipments are sent with tracking available for online viewing.
