

DECLARATION OF TIMOTHY CASEY IN SUPPORT OF CLERK'S CERTIFICATE

I, TIMOTHY CASEY, pursuant to 28 U.S.C. § 1746, declare as follows:

NOTING DEFAULT OF DEFENDANT DEEP SHAH

- 1. I am employed as an attorney in the New York Regional Office of Plaintiff
 Securities and Exchange Commission (the "Commission"). I submit this Declaration in support
 of the Commission's application, pursuant to Fed. R. Civ. P. 55(a) and Local Rule 55.1, for a
 Clerk's Certificate Noting Default of Defendant Deep Shah ("Shah").
- 2. I am familiar with the facts and proceedings in this action and the allegations in the Commission's Second Amended Complaint. I make this declaration upon information and belief, the sources of which are documents obtained by the Commission and conversations with other members of the Commission's staff. The documents that I reviewed include the docket maintained by the Court in this matter and documents obtained by the Commission staff during the course of this litigation.
- 3. Upon information and belief, Shah is a person who is not an infant, in the military or an incompetent person.
 - 4. The Commission filed its Complaint in this matter on October 16, 2009.
 - 5. On November 5, 2009, the Commission filed an Amended Complaint.
 - 6. On January 29, 2010, the Commission filed a Second Amended Complaint.
- 7. On March 22, 2010, copies of the Second Amended Summons issued to Shah and the Second Amended Complaint were served on Shah by the Department of Legal Affairs of the Ministry of Law and Justice of India. Proof of such service was filed with the Court on March 4, 2011.
 - 8. As indicated in the docket, Shah's Answer was due no later than May 21, 2010.
- 9. Shah has failed to appear personally or through counsel in connection with this litigation.

- 10. Shah has failed to plead or otherwise defend this action as provided for by the Federal Rules of Civil Procedure and the Local Civil Rules.
 - 11. Shah is in default.

Accordingly, a Certificate of Default should be issued by the Clerk of this Court and a judgment by default should be entered against Shah.
